Overview of the TD Mobile Pay Solution

The purpose of this guide

This guide will provide helpful information about the equipment, its features, and TD Merchant Solutions. Please ensure you read this guide so that you become familiar with the capabilities of TD Mobile Pay and how it can support your business needs.

This guide provides instruction on the use and functionality of the TD Mobile Pay solution. The provision of Visa®, MasterCard®, American Express® and / or Interac® Direct Payment merchant services to you (the user) by TD Merchant Solutions is governed by the Merchant Services Agreement and any other agreement(s) that govern the services that we may provide to you.

The use of the TD Mobile Pay solution with respect to the provision of merchant services by a third party is governed by any agreement(s) with such third party.

Requirements

- A mobile phone with a recent version of the Android™ or iOS™ operating system
- A mobile phone that:
 - is Bluetooth[®] Low Energy (BLE) compatible
 - has a camera if you wish to add images to the Product catalog

What is the TD Mobile Pay solution?

The TD Mobile Pay solution is comprised of two components.

The card reader and the mobile application

The card reader and the mobile phone app work together as one solution.

- The TD Mobile Pay app is like your electronic cash register where you enter the customer's purchase, and the card reader is where the customer pays for their purchase with their credit or debit card.
- On the TD Mobile Pay app you can:
 - connect to the card reader via Bluetooth,
 - review transactions,
 - perform refunds / voids,
 - administer your product catalog, and
 - administer your account.





The Merchant Portal

The merchant portal is a website that mimics the administration capabilities of the smartphone app and is accessible via web browser. You can:

- review transactions and perform refunds / voids,
- administer user accounts,
 - pull reports and review your monthly statements.

The card reader

The card reader allows the customer to enter financial transaction information. Refer to the diagram to the right to familiarize yourself with the terminal layout.

- 1. Power key
 - Press to power the terminal on.
 - Press and hold for 3 seconds to power the terminal off.
- 2. Command keys

In order left to right, Cancel, Correction, and \mbox{OK} / $\mbox{Enter}.$

- 3. Card readers
 - a) Swipe cards
 - b) Insert chipped cards
 - c) Contactless cards

Screens

There are two main screens that you will use to navigate the card reader. They are the:

- Idle screen
- Menu screen

Idle screen

The default screen is called the Idle screen. It displays important information and icons. They are:

1. Bluetooth icon

You will see the Bluetooth icon on this bar will be different depending on which setup or comms method is chosen.

The grey icon indicates that Bluetooth is not connected to the TD Mobile Pay app.

The orange icon indicates that the card reader is connecting to the TD Mobile Pay app.

The green icon indicates that the card reader is connected to the TD Mobile Pay app.


2. Power

The battery icon in the top-right corner indicates the terminal battery level. When the charging plug icon appears in the top-right it means it is charging.

3. Menu

Press this to open the **Menu** screen.






Menu screen

The screen displays the following icons: **Settings**, **Device Info**, and **Service**.

The Settings menu contains the *BLE (Bluetooth) Configuration* and the card reader *Speaker Volume* menus. To access the Settings screen, you will need to enter a four-digit passcode. This passcode is the last numbers of the Device ID on the back of the card reader and begins with LW.

The Device Info screen displays the card reader information such as **Terminal ID** and **Serial Number**.

The Service screen is only used by TD Merchant Solutions Technicians.



Card reader battery / sleep mode

Please note that your card reader will go into sleep mode if it is not used for 20 to 30 seconds to conserve battery life. The card reader will automatically wake up when:

- you log into the TD Mobile Pay app,
- the application is trying to connect to the reader, or
- the debit / credit payment icon is selected.

TD Mobile Pay application


There are three main screens that you will frequently use to navigate the mobile application. They are the:

- New Sale screen,
- Connection Manager screen, and
- Menu screen.

New Sale screen

The New Sale screen is the default screen once you log into the TD Mobile Pay app. From here you can do the following:

Icon	Description
Menu	This icon accesses the Menu screen where you can access: New Sale, Dashboard, Product Catalog, Card Readers, Sales History, and Settings.
Search	This icon is only used if you have created a product catalog. If you have, you can search for an existing product.
Cart	This icon displays whether there is an existing sale in progress with a number indicating the number of items. If you press this icon, you can access the existing sale and submit it for payment.
Quick Sale	This icon allows you to perform a sale without using items in the product catalog.
New Product	This icon allows you to quickly add a new product to your product catalog. It will no longer appear once you create your first product. You must then use the Product Catalog option to add products.



Connection Manager screen

The Connection Manager screen is where you can review, find, and connect the TD Mobile Pay app to a card reader. From here you will see the following:

Icon / Button	Description
Menu	This icon accesses the Menu screen where you can access: New Sale, Dashboard, Product Catalog, Card Readers, Sales History, and Settings.
New Sale	This icon will take you to the New Sale screen.
Scan	Press this button to search for nearby active card readers to connect the TD Mobile Pay app to.
Bonded Devices (Android)	This section displays which card reader is currently connected to the TD Mobile Pay app. The bonded device must have green checkmark to be able to process transactions.
Available Devices (Android)	This section displays all the card readers that are available to be connected to the TD Mobile Pay app. If you don't have a bonded device, you will see the option to start the Card Reader Wizard in this section.
Devices (iOS)	This section displays the card reader that is currently connected to the TD Mobile Pay app and any other available card readers.




Android

Menu screen

The Menu screen is where you access configuration and information on your solution. In the top-left corner you will see the application status and indicates whether the TD Mobile Pay app is connected to a card reader (Ready for use) or is not connected (Action Required). From this menu you can access the following:

Icon	Description
Connection Manager	This is the three dots in the top-right corner of the screen, and it will take you to the Connection Manager screen to connect a card reader to the TD Mobile Pay app.
New Sale	This will take you to the New Sale screen.
Dashboard	This will take you to the Dashboard screen to show high level sales information for your business.
Product Catalog	This will allow you to add, edit, or remove items and categories from your Product Catalog.
Card Readers	This will take you to the Card Readers screen and allow you to view your card reader status.
Sales History	This will take you to the Sales History screen to show detailed sales information for your business.
Current Batch	This will take you to the Current Batch screen and shows the transactions that have not been sent for settlement.
Support	This displays contact information and a link to the Troubleshooting Wizard to help you connect your card reader to the TD Mobile Pay app.
Settings	This is the gear icon in the bottom-left corner of the screen and will take you to the Settings screen where you can access and change your personal profile, view your business profile, and modify

the receipt message.

Close Menu	This will close the menu.

Merchant Portal

The Merchant Portal is an online website that allows you to monitor and update your account, to view reports and analytics, and track your sales. The information is arranged into the following tabs:

- Dashboard a quick overview of current and historical transactions
- Sales History a detailed view of transactions
- Reports three reports (Detailed Transactions, Product Sales, and Tax)
- Batches access closed batches and current open batch by Card Reader
- Card Readers a list of the terminals used by your business
- Staff add, edit, and delete user IDs for your business
- Settings view and edit your login profile, view your business profile, and edit the custom message on your receipt

Fraud prevention

The following information will help you protect yourself from fraudulent transactions.

Manually entered credit card transactions

Your business may or may not accept manual credit card entry. There is an inherent risk associated with these transactions as they have an increased rate of fraud. If you do manually enter a credit card transaction which is deemed fraudulent, you will be held responsible for any chargebacks associated with it. Manually entered credit card transactions also include mail order and telephone order transactions.

If you are uncomfortable manually entering a credit card it's within your rights as a business owner to request another form of payment (debit, cash, etc.).

Financial Transactions

All financial transactions must be initiated from the TD Mobile Pay application and payment must be received via the card reader.

New Sale

Before starting a sale ensure that your card reader:

- is awake.
- status in the top-left corner reads **Ready for Use** and there is there is a green checkmark on the **card reader** icon.

There are two ways to perform a sale. They are **Select Product** or **Quick Sale**.

Select Product

You would perform this when you have already entered the product on the application so that it can be selected from a list of available products on the catalog.


Quick Sale

You would perform this when the product cannot be selected from a list of available products on the catalog.

Select product

- 1. On the TD Mobile app: Go to the **New Sale** screen.
- 2. Select the **product** for purchase and the **Add to Cart** screen appears.
- Enter the quantity for sale by pressing the +/- buttons or manually entering in the quantity.
- 4. Select the Add to Cart to add the item to the cart. Repeat steps 2-4 to add any additional products to the cart. When finished go to Step 5.
- 5. Press the **Cart** icon in the top-right corner of the screen or the **Subtotal** button at the bottom of the screen. You can make changes to the sale here before submitting the products for payment. Swipe the product to the left or tap it to access the **Edit** and **Delete** buttons.
- 6. Press Select Payment and go to Select Payment on the next page.





Quick sale

- 1. On the TD Mobile app: Go to the **New Sale** screen.
- 2. Select Quick Sale.
- 3. Enter a product or service name. (optional)
- 4. Specify a **price** for the product or service.
- 5. Select the appropriate taxes. (optional)
 - a) Choose the applicable tax or taxes. (See *Manage your taxes* to define what taxes are available on this screen.)

For example, if you'd like to sell something for a total of \$10.00 with tax included, but don't want to calculate what the base price is, the app can do it for you. You can enter \$10, check **Tax Included in Price**, choose the applicable tax and the app will calculate the base price and it will show it on the **Cart** screen.

- **b)** You can select **Tax Included in Price** if you'd like the tax to be included in the price.
- c) Press Confirm.
- 6. Enter the **quantity** for sale by pressing the +/- buttons or **manually entering** in the quantity.
- 7. Press Add to Cart to add the item to the cart. Repeat steps 2-7 to add any additional products to the cart. When finished go to Step 8.

- 8. Press the **Cart** icon in the top-right corner of the screen or the **Subtotal** button at the bottom of the screen. You can make changes to the sale here before submitting the products for payment. Swipe the product to the left to access the **Edit** and **Delete** buttons.
- 9. Press Select Payment and go to Select Payment.

Select payment

1. On the TD Mobile app: Select the payment method for your sale: **Debit/Credit**, **Credit** (Manual Entry), or **Cash**.

Debit/Credit

Selecting Debit/Credit allows you to accept a Debit or Credit payment by having a customer **Insert / Tap / Swipe** their card or **Tap** their digital wallet. Do not use this option when you must manually enter a credit card.

If tips are enabled on your card reader, the customer will be prompted to optionally enter a tip (**percentage** or **dollar amount**) before presenting their card. Tips are disabled by default. If you wish to activate tips please call the TD Merchant Solutions Help Desk at **1-800-363-1163**.

Credit (Manual Entry)

This option may not be visible on your application as it depends on which transaction types your business allows. You may see up to three options. To enable certain features, such as manual card entry, tips, etc., you must call the TD Merchant SOlutions COntact Centre **(1-800-363-1163)**.

Please select the appropriate transaction:

- Card Present Manual Entry
- Card Not Present Phone Order
- Card Not Present Mail Order

If tips are enabled on your card reader, the customer will be prompted to optionally enter a tip (**percentage** or **dollar amount**) for manual entry before presenting their card. Tips are disabled by default. (card present only)

The customer confirms the final amount. (card present only)

You will enter the following on the card reader: **card number** (all), **expiration date** (all), and the **DVC** (Manual Entry and Phone Order only) on the back of the credit card.

<u>Cash</u>

Selecting **Cash** will allow you to record your payment. You will be responsible for collecting cash and dispensing the correct change. The screen allows you to type in the amount tendered by the customer and it will display the change due. The application offers four pre-populated **quick amounts**.

Press Submit.

2. A summary page will display. From here you can choose to **Send Receipt** to the customer via email and / or a mobile number or press **Done** to complete the transaction without sending a receipt.

Discounts

You can apply a discount to all or a selection of items for purchase. The TD Mobile Pay app supports percentage (%) and dollar amount (\$) based discounts.


- Discounts entered as a dollar amount will be applied across all selected products based on a unit price. For example, if you selected 2 items of \$50 and \$100 each. Applying a \$9 discount would result in the first item being discounted \$3 and the second item being discounted \$6.
- You can only apply one discount type (Amount **OR** Percentage) to a transaction, but it can be applied to specific items in the cart versus the entire cart.
- These discounts remain after this transaction so be careful when you apply discounts for one-off discounts. If a discount is not removed, that same discount will be applied to future txns until the discount is edited or removed.

Add a discount:

- 1. On the TD Mobile app: Select your **item(s) for sale** and press **Cart** or the **Subtotal** bar on the bottom of the screen.
- 2. Press ADD next to the *Discount* line item. The *Discounted Items* screen appears.
- **3.** Select the checkbox next to the item(s) that you want to discount. All quantities for the selected item(s) will be discounted. Press **Next**.
- 4. Select the discount option: Amount (\$) or Percentage (%).
- 5. Enter the discount amount and press **Apply**. You will be returned to the *Cart* screen. It will display the items in the cart with the discount applied. In this case we have discounted the coffee 10% so it went from \$10.00 to \$9.00 for just the coffee.



Edit a discount:

- 1. On the TD Mobile app: Select **New Sale** \rightarrow Cart screen.
- 2. Press Edit next to discount.
- **3.** Select the checkbox next to the item(s) that you want to discount. All quantities for the selected item(s) will be discounted.
- 4. Press Next.
- 5. Select the discount option: Amount (\$) or Percentage (%).
- 6. Update the discount amount and press **Apply** to set the new discount amount. You will be returned to the *Cart* screen.

Voids and refunds

You can manage voids and refunds within the TD Mobile Pay app by accessing your Sales History. Find the specific transaction and view your options below.

You will not see a void option if:

- a partial refund has already been performed on the transaction OR
- the transaction was performed on a prior day and has been submitted for settlement.

Voids

You would void a transaction that was performed on the current day. When you void a transaction **all monies** (sale amount, tips and taxes) will be returned to the customer; there are no partial voids. To perform a void:

- 1. On the TD Mobile app: Select **Menu** \rightarrow Sales History.
- 2. Select the transaction to be voided.
- 3. Press Void.
- 4. Review the summary and press Void.
- 5. Follow the on-screen prompts based on the payment method available for void.

Refunds

You would refund a transaction if a partial amount is required or if the transaction took place on a prior day. Refunds should always be performed to the same payment method and card number whenever possible. To perform a refund:

- 1. On the TD Mobile app: Select **Menu** → Sales History.
- 2. Select the transaction to be refunded.
- 3. Press Refund.
- 4. Select the items for refund by pressing the +/- buttons next to the appropriate products. The tip can also be selected for refund by selecting the **Refund Tip** checkbox. By default it is not selected.
- 5. Once all items are added, tap the **Subtotal** button to go to the **Refund Summary** screen.
- 6. Review your selections and press **Refund**.
- 7. Follow the on-screen prompts based on the payment method available for refund.

Receipts

Receipt example

Each transaction has a receipt and most of the information is purely for record keeping. There are some points of important information you need to be aware of to ensure that your transactions have completed correctly.

Order #: The order number associated with the transaction which is generated by the solution.

Transaction Type: This shows what type of transaction was done (Sale, Void, etc.).

Card Type: This shows what kind of card was used for the transaction (Interac, Visa, Mastercard, American Express). Cash transactions will not have this information.

Card Number: The masked number of the card used for the transaction. Cash transactions will not have this information.

Auth Number: The authorization number associated with the transaction. Cash transactions will not have this information.

Entry Method: This is how the card was used (contactless, chip, etc.). Cash transactions will not have this information.

Approved: Always ensure that debit and credit sales are approved before completing the transaction as it could be **Declined**.

Resend a receipt

If a customer requests that you send them a receipt from a past transaction, you can resend the PDF receipt to a their email address or mobile number.

The receipt is attached when sending to an email address. A secure link is provided to download the receipt when sending to a mobile number.

To resend a receipt:

- On the TD Mobile Pay app: Select Menu → Sales History.
 On the Merchant Portal: Select Sales History.
- 2. Select the transaction.
- 3. Press Send Receipt.
- 4. Enter the customer's email address and / or mobile number and press Send Receipt.

Download a receipt

If you wish to save a copy of a transaction receipt, you can download a PDF copy on the **Sales Details** screen. To download a receipt:

- 1. On the Merchant Portal: Select **Sales History**.
- 2. Select a transaction to view the details.
- 3. Press View Receipt to download the receipt.

Reviewing sales

With TD Mobile Pay, you can track daily sales statistics performed by you or your staff.

The **Dashboard** provides a real-time summary of your sales, including total sales, refunds, taxes, and tips. You can view the information by payment type or by the staff member that conducted the transaction.

The **Sales History** allows you to review a list of your previous sales. You may click on the row of a transaction to see more detail and resend a receipt. When you need to find a specific transaction, you can browse by payment type, date range or staff member that conducted that transaction.


Need to find a past transaction? You can track your historical transactions from the past 18 months.

Dashboard

To view the Dashboard:

- 1. On the TD Mobile Pay app: Select **Menu** \rightarrow Dashboard.
 - On the Merchant Portal: Select **Dashboard**.
- **2.** The following information will be displayed for the specified date range.
 - **Total Sales:** This is the total sales dollar figure that your business has transacted in the last month. It will also display the percentage change over the selected time periods.
 - **Number of Sales:** This is the total number of sales that your business has transacted in the last month. It will also display the change over the selected time periods.
 - **Total Refunds:** This is the total refund dollar figure that your business has transacted in the last month. It will also display the change over the selected time periods.
 - **Number of Refunds:** This is the total number of refunds that your business has transacted in the last month. It will also display the change over the selected time periods.

- **Total Tips:** This is the total tip dollar figure that your business has collected in the last month. It will also display the change over the selected time.
- **Total Tax Collected:** This is the total tax dollar figure that your business has collected in the last month. It will also display the change over the selected time periods.
- Last Transaction: This is the time stamp of the last transaction that your business has performed. This information will not change until a new transaction takes place. It will not change by selecting a new filter.
- 3. You can filter your results by selecting them from the drop-down menus on the Merchant Portal or select the **Filter** icon in the bottom-right corner of the TD Mobile Pay app. The following filters can be applied:
 - User View: All Users/Business (default) or an Individual.
 - Payment Method: Credit, Debit or Cash.
 - **Date Range:** Today, Yesterday, Last 7 Days, Last 30 Days, This Month, Last Month, or Custom Range. Whatever date range you select, it will compare your current transactions against historical transactions of the same time range. For example, if your date range is Last 7 Days, then it will use the 7 Days prior for comparison.



Sales history

To view the Sales History:

- On the TD Mobile Pay app: Select Menu → Sales History.
 On the Merchant Portal: Select Sales History.
- 2. The following information will be displayed for each transaction that took place between specified date range.
 - **Date:** This is the transaction date.
 - **Time:** This is the time that the transaction took place.
 - Order Number: This is the invoice number.
 - Items Sold: This is the number of items in the transaction.
 - **Users:** This is the user who performed the transaction.
 - **Transaction Type:** This is the type of transaction performed. There are three possibilities: Sale, Refund, Void.

- **Payment Type:** This is the payment type used to pay for the transaction. There are three possibilities: Credit, Debit, or Cash.
- **Card Type:** This is the type of card used to pay for the transaction. The possibilities are: Visa, MC, AE, and Interac.
- Total: This is the total amount of the transaction including tax and tip.
- **Status:** This is the status of the transaction. There are three possibilities: Approved, Declined, or Not Completed.
- **3.** You can filter your results by selecting them from the drop-down menus on the Merchant Portal or by pressing the Filter icon in the bottom-right corner of the TD Mobile Pay app. The following filters can be applied:
 - User View: All Users/Business (default) or an Individual.

Settlement

A settlement must be performed on each terminal to maintain accurate records and balance your accounts. This is important as it closes all open batches and starts a new batch on the terminal.

There are two options for closing batches on the TD Mobile Pay solution: **Automatic Batch Close** (default) and **Manual Batch Close**. Only one batch close option may be enabled at once — Automatic or Manual, not both. You must contact the TD Merchant Solutions Contact Centre at **1-800-363-1163** to enable Manual Close Batch.

Automatic Batch Close

The TD Mobile Pay solution automatically performs a daily settlement each night at 23:59 EST.

Manual Batch Close

The TD Mobile Pay solution must have its batch closed manually by the user. You will only see this menu option if you have enabled Manual Batch Close.

- 1. On the TD Mobile Pay app: Select **Menu** → Review Batch Details.
- 2. Press Close Batch. A confirmation screen appears.
- **3.** Press **Done** to close the batch. The batch is now closed, and a new batch has been automatically opened.

Configuration

Manage your product catalog from the Merchant Portal

You can manage your commonly sold products and services via the TD Mobile Pay Merchant Portal by accessing your Product Catalog.

- If your business has staff users, they will be able to access and sell products from your catalog but will not be able to make changes to it only the business owner can make changes to the Product Catalog.
- The products in the catalog are sorted by name in alphabetical order. If you are having trouble finding a product, you can press the **search** icon to reveal the search bar.



- 2. Press Add Tax.
- 3. Select the *Tax Label* drop-down menu and one of the prepopulated taxes (GST, HST, PST, or QST). These are the only tax options; you may not create a new tax label.
- 4. Enter the **Tax Rate** percentage.
- 5. Indicate whether the tax is **enabled** or **disabled**. If a tax is disabled it means that it cannot be used for any products, but it is still saved to your Merchant Portal for future use. Default is enabled.

Delete a tax

To delete a tax:

1. On the TD Mobile Pay app: Select **Menu** \rightarrow Settings \rightarrow Receipts.

On the Merchant Portal: Select **Settings** \rightarrow Receipt.

- 2. Enter your receipt footer message In the *Footer Message* box up to 120 characters. You will see what is entered appear in the *Receipt Preview* to the right.
- **3.** Press **Save** once you are satisfied with your message.

Manage your card readers

The card readers screen lists the card readers associated to your merchant account, including, Make, Model, Merchant ID associated with it, Terminal ID, Alias (user-friendly or descriptive name), Serial Number, Activation Date, Last Connection Date, and Status.

View a card reader

To view your card readers:

1. On the TD Mobile Pay app: Select **Menu** \rightarrow Card Readers \rightarrow Select a card reader to view.

On the Merchant Portal: Select **Card Readers** → Select a card reader to view.

Connecting to your card reader

Once you have paired, activated and connected to your card reader for the first time, you will not need to pair or activate the card reader anymore. The following will explain how you can connect to your card reader in the future any time you log in.

Connecting Automatically

Once you log in to the app, if the card reader is powered on and connected to your mobile device via Bluetooth, the TD Mobile Pay app will automatically attempt to connect to the card reader.

In the menu and in the Connection Manager you will be able to see states transition from **Scanning** to **Connecting** to **Ready for Use**.

To view the card reader status:

- 1. Open the application menu. You can do this by swiping the application from the left edge of the screen to the right or by pressing the **Menu** icon.
- 2. The status of the card reader can also be viewed in the **Connection Manager**. You can access the Connection Manager by pressing the **three dots** to the right of the status.

Connecting Manually

In case the card reader was not powered **ON** when you logged in, the app might not be able to automatically connect to your card reader. In this case, you'll need to manually connect.

To manually connect your Card Reader:

- 1. On the TD Mobile Pay app: Select Menu \rightarrow Connection Manager $\stackrel{\text{\tiny CO}}{\longrightarrow}$
- 2. Press Scan. The app will start scanning.
- 3. Once the scan is complete you will be able to see all the card readers that are available for connection.
- 4. Select the card reader you would like to connect to.
- 5. Once the card reader has connected you will see a green check mark in the top right corner of the card reader you have selected. Now you're ready to process card transactions.

Edit a card reader's name (alias)

You can assign a user-friendly alias name to each card reader for easier identification on the Mobile App and Merchant Portal. To update a card reader's name:

1. On the TD Mobile Pay app: Select **Menu** \rightarrow Card Readers \rightarrow Select a card reader.

On the Merchant Portal: Select **Card Readers** → Select a card reader.

- 2. Press Edit / Edit Alias for the desired card reader.
- 3. Enter the new Alias (Name) and press Save.

Reinitialize a card reader

If your card reader's Bluetooth connection to your mobile device is working but you are unable to perform transactions, you can try reinitializing your card reader. To reinitialize a card reader:

- 1. On the TD Mobile Pay app: Select **Menu** → Support.
- 2. Press Initialize Now.
- **3.** The initialization process may take a few minutes. Once it is completed, you will see a confirmation screen. The card reader status will display **Ready for Use**.

Deactivate a card reader

- On the TD Mobile Pay app: Select Menu → card readers → Select a card reader.
 On the Merchant Portal: Select card readers → Select a card reader.
- 2. Press Deactivate.
- 3. Press Deactivate / Yes to confirm. Once the card reader is deactivated, you cannot reactivate it.

Adjust a card reader's volume

To increase / decrease the volume on the card reader:

- 1. On the card reader: Select **Menu** \rightarrow Settings.
- 2. Enter your **Passcode**. The passcode is the last four digits of the serial number located on the back of the card reader (e.g. LW#####).
- 3. Press Speaker Volume.
- 4. Press or + to adjust the card readers volume. Each press will decrease or increase the volume by 10%. The default volume setting is 50%.

Bonding and connectivity

Re-establish Bluetooth connection

If your Card Reader and mobile phone lose connection at any time, perform the following steps:

- 1. On Card Reader: Select Menu \rightarrow BLE Configuration \rightarrow BLE Restart.
- 2. The Card Reader and your mobile phone will attempt to re-establish their connection.

Manually bond your Card Reader and mobile phone

To manually bond your Card Reader to your mobile phone, follow the instructions below.

On the Card Reader:

- 1. Press Menu and then press Settings.
- 2. Enter your **passcode** and press . The passcode is the last four digits of the serial number located on the back of the Card Reader (e.g. LW######).

3. Press BLE Configuration.

- 4. Press BLE Bonding.
- 5. Press (1). Your Card Reader will now show **Ready for Bonding Please initiate bonding on phone**.
- 6. You may now perform the steps on your mobile phone.

On your mobile phone:

- 1. Press the **Connection Manager** icon, press **Connection Manager** and select your displayed Card Reader. The passkey should now display on the Card Reader.
- 2. If the passkey is not generated, please go to *Troubleshooting and information How do I generate a passkey?*. Otherwise proceed to the next step.
- **3.** Enter the passkey from the Card Reader and press **Pair**. Your Card Reader is now physically bonded to your phone.
- 4. The Activate Card Reader? screen will appear on your TD Mobile Pay app. Press Start.
- Press Finish to close the Card Reader wizard. Your TD Mobile Pay application is now bonded to your card reader — shown by a green check mark on the phone icon in the Connection Manager screen (see image to the right).



6. You are now ready to accept debit and credit card payments! If you don't see the green check mark, go to **Connections Manager**, and press your Card Reader to initiate the connection.

Remove bonding

If for any reason you wish to remove the bond between your mobile phone and Card Reader (new mobile phone, reattempt a bad bond, etc.), you can easily disconnect it by following these steps.

- 1. On Card Reader: Select Menu → BLE Configuration → Remove Bonding.
- Your mobile phone is now disconnected from the Card Reader. To verify this, refer to *Current bonded device*.

Signing In using an Authentication App MFA

- Q: When I'm trying to log in, I'm asked for a verification code, but I can't access it because I deleted my account in the authenticator app. What should I do?
- A: Call the TD Merchant Solutions Contact Centre at **1-800-363-1163** to reset your MFA preference so you can set up a new account in your authenticator app.
- Q: When I'm trying to log in, I'm asked for a verification code, but I can't access it because I deleted the authenticator app. What should I do?

A: Call the TD Merchant Solutions Contact Centre at **1-800-363-1163** to reset your MFA preference so you can set up a new authenticator app or you can choose to use SMS instead as your MFA preference.

- Q: When I'm trying to log in, I'm asked for a verification code, but I can't access it because I don't have access to the device where the authenticator app is located. What should I do?
- A: Contact the TD Merchant Solutions Contact Centre at **1-800-363-1163** to reset your MFA preference so you can choose to use SMS instead as you MFA preference.

Forgot Your Password

- Q: I clicked on the Forgot Password link and entered my email, but I did not receive an email with the temporary code that I need to reset my password. What should I do?
- A: Emails are often delivered to spam, junk or secondary inboxes without us noticing. If the email cannot be found within one of these folders, try Forgot Password again and make sure that you entered your email address correctly.

If you haven't completed your account setup, locate your Welcome email and follow the instructions to set your password. You need to complete your account setup before you're able to use the Forgot Password option. If you cannot find your Welcome email, call the TD Merchant Solutions Contact Centre at **1-800-363-1163** to resend you the Welcome email.

Connecting to your card reader

- Q: I'm getting an Unsupported location error when trying to connect to the card reader or when I'm trying to process a transaction. What should I do?
- A: You can only connect to your card reader and process transactions if you are in Canada. If you are in Canada and are still having this issue, you can try the following:
 - 1. Confirm Location Services are turned **ON** and permissions are granted for the TD Mobile Pay app.
 - 2. Confirm your time zone is accurate on your mobile device.
 - 3. If you are using a VPN connection, make sure it's connecting through servers in Canada.
 - **4.** If you are somewhere that might be difficult for your mobile device to locate you (e.g. in a basement), retry from a different location.
 - 5. If you are close to the Canadian border, call the TD Merchant Solutions Contact Centre at 1-800-363-1163.

Q: I cannot pair to my card reader for the first time. What should I do?

A: Make sure that the card reader is in bonding mode while trying to pair.

Accepting payment

Q: I received an error "Payments are only accepted within Canada." What does that mean?

A: This means that the mobile phone that you are using does not have its **Location Services** set to **Canada**. Please refer to your mobile phone's documentation and set your location as **Canada**.

If you are using a VPN, you must also have this set to Canada, otherwise the service will not be usable.

Q: I tried to process a card transaction and it says that it's "In Progress". What does that mean?

A: The mobile app communicates with the card reader via Bluetooth and with our servers through the Internet to complete a transaction. If a message gets lost or interrupted due to issues in transit, you may see an *In Progress* status. Please go to the Sale History and wait a couple of minutes to see what the final state will be.

In many cases the result will be **Not Completed** which means the transaction failed and you can try to process another transaction. If it says **Approved**, the transaction completed successfully, and you do not need to retry.

What do I do if the card reader displays a security alert?

If your card reader displays the message **Security Alert**, it means that your terminal has been damaged and must be replaced. Call the TD Merchant Solutions Contact Centre immediately at **1-800-363-1163**.

Reference

Storing the card reader

- It must be stored in temperatures between 0° and 50° Celsius.
- Do not leave it outdoors overnight, especially in the winter.

Maintaining the card reader

- Don't place the card reader on a magnetized pad this will cause them to malfunction.
- Routinely clean it with a damp cloth so that any spills don't get into the inner workings.
- Use TD-approved cleaning cards for the chip and magnetic card readers.

Lost or stolen equipment

If your device has been lost or stolen, please:

- 1. Deactivate your card reader via the TD Mobile Pay app or the Merchant Portal. (lost or stolen)
- 2. Call the TD Merchant Solutions Contact Centre immediately at **1-800-363-1163** to report the incident. (lost or stolen)
- **3.** Contact the police to file a report. (stolen only)

What should I do when the police arrive regarding the stolen device?

If a police officer arrives on site. please record the following:

- Officer's name
- Officer's jurisdiction
- Officer's contact information
- Stolen device's serial number

The officer should provide you with a **report number**. After obtaining the above from the officer, please call the TD Merchant Solutions Contact Centre and provide this information so that you can receive a replacement device.
